SUMMARY ANNUAL REPORT TRI-COM CONSULTING GROUP LLC 401(K) PROFIT SHARING PLAN & TRUST

This is a summary of the annual report for the TRI-COM CONSULTING GROUP LLC 401(K) PROFIT SHARING PLAN & TRUST, EIN 06-1455911, Plan No. 001, for the plan year ending December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided through a trust fund. Plan expenses were \$268,348. These expenses included \$0 in administrative expenses, \$265,168 in benefits paid to participants and beneficiaries and \$3,180 in other expenses. A total of 107 persons were participants in or beneficiaries of the Plan at the end of the plan year, although not all participants had yet earned the right to receive benefits.

The U.S. Department of Labor's regulations require that an independent qualified public accountant audit the Plan's financial statements unless certain conditions are met for the audit requirement to be waived. The Plan met the audit waiver conditions for 2017 and therefore has not had an audit performed. Instead, the following information is provided to assist you in verifying that the assets reported in the Form 5500 were actually held by the Plan.

The Plan's assets are invested in qualifying Plan assets. The value of Plan assets was \$3,526,503 as of December 31, 2017, compared to \$2,996,301 as of January 1, 2017. During the plan year, the Plan experienced an increase in its net assets of \$530,202. This increase included unrealized appreciation or depreciation in the value of the Plan assets; that is, the difference between the value of Plan assets at the end of the year and the value of the Plan assets at the beginning of the year or the cost of assets acquired during the year. The plan had a total income of \$798,550 including employer contributions of \$0, employee contributions of \$339,491, and earnings from investments of \$459,059.

At the end of 2017, the Plan had \$3,526,503 in assets held by MATC (the "Financial Institution").
